A copy of the organization's letters patent (only in the case of a first-time application).

A copy of the most recent audited financial statements.

The list of members of the Board of Directors.

A copy of the last annual report or activity report.

To facilitate submission and follow-up of applications, we have developed a short identification sheet for applicant organizations. This document must be included with each application submitted to us and is available for download from the funder website.


